rear rail assembly (rear longitudinal armatures) installed as part of an aftermarket repair, may not have the specified structural strength due to a number of spot welds being missed during service part manufacture.

Description of the Safety Risk: Vehicles in this condition are at risk of the rear bumper beam detaching
