Description of the Defect : The FMVSS 120 weight Label has the incorrect occupant cargo carrying capacity.

FMVSS 1 : 120 - Wheels and rims- other than passenger cars

Description of the Safety Risk : The owner may overload the vehicle without the proper carrying capacity listed on the label. This may create an increased risk of crash.

Description of the Cause : There was an error in the software that populates the weight label.

Description of Remedy :

Description of Remedy Program : Airstream will issue new FMVSS 120 weight labels with the cargo carrying capacity. Reimbursement will be provided through normal warranty claims process.

How Remedy Component Differs from Recalled Component : Remedied label has the corrected weight value.
