dealer to inspect the securement of the overhead cabinet doors of certain 2020 & 2021 model year Airstream Globetrotters. If any of the overhead cabinet doors are found to be loose, the loose cabinet doors will need to be

replaced.

How Remedy Component Differs There is not a distinguishable difference in the appearance of the secured from Recalled Component: cabinet door. The date of manufacture on the Federal Certification Label would be the way to determine if the overhead cabinet door securement is correct. Any unit manufactured after 7/31/2020 would have a properly

secured cabinet doors.
