On Thursday May 6, Shyft received a complaint that indicated the rear suspension mounting brackets that are to be welded to the rear axle had failed on a motorhome. On the same day, Dana indicated there were 8 other axles subject to the same process deviation that resulted in missing welds and supplied serial numbers of those axles. Shyft worked to identify the correlating chassis VIN's and locations of the completed vehicles. On Thursday, May 13, 2021, Shyft determined that a safety related defect could exist in these vehicles.

## **Description of Remedy:**

Description of Remedy Program : The rear suspension mounting brackets will be inspected for conforming

welds. If a weld(s) is found to be non-conforming, the rear drive axle will be replaced at no charge. All suspect vehicles are within their warranty
