April 22 2021 PSWG Investigation Opened, May 13 2021, Hub covers are no longer shipped from our factory with our vehicles (Containment activity). May 17 2021 Product Safety Working Group Reviews findings of investigation and field reports, decision made to raise to Product Safety Committee. May 27 2021 Volvo Product Safety Committee determines a safety related defect. June 2 2021 Volvo notifies NHTSA that a voluntary recall will performed to address this issue. We have nineteen warranty claims associated with this issue.

#### **Description of Remedy:**

Description of Remedy Program: Recall actions will be to have customers bring vehicles to dealers/

authorized service centers and have the hub cover removed. The removal of the hub covers is the remedy as it removes the safety hazard. When an appropriate solution is available, those customers will then be notified under a separate campaign (service program) will be used to address the

hub cover replacement.
