**Description of the Defect :** The shackle nuts may not be tight. This condition can allow the shackle nuts to rotate off the shackle bolt.

**Description of the Safety Risk :** Insufficient tightening of the shackle nuts may cause the axle/suspension to detach from the vehicle which may cause loss of vehicle control which may lead to a crash, property damage, personal injury or death.

On June 3, 2021, the dealership pre-delivery inspection team contacted the manufacturing plant. The manufacturing plant locked down their yard, inspected, and remedied all vehicles as needed.

On June 7, 2021, the manufacturing plant was able to determine that vehicles of this same model had in fact shipped.

On June 8, 2021, the manufacturing plant contacted Forest Rivers Office of Corporate Compliance (OCC) and an investigation was opened.

On June 11, 2021, Forest Rivers Corporate Recall Committee voted to recall.

## Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor free of charge to the Consumer and Dealer. An Authorized Forest River Dealer or Service Center will need to perform the remedy to ensure the shackle bolts are properly tightened.
