On 5/27/2021, Product Safety and Compliance was asked by engineering to review FMVSS 110 for seating capacity requirements on the required tire and loading information placard. Product Safety and Compliance informed engineering the seating capacity is indeed a requirement to be on the label. On June 1, 2021, it was determined there are 80 units outside of Shyft's direct control impacted by this condition. Product Safety and compliance conducted a review of past precedence by other manufacturers for a similar condition. On June 13, 2021 this review was completed and on June 14, 2021, The Shyft Group, Inc. determine a non-compliance to FMVSS 110 could exist in the affected vehicles.
