Certain metallic electrical boxes may not be grounded as required by NFPA 70 Article 551.55(C)(2). The metallic box is being used as a substitute for a non-metallic box due to a component supplier shortage. 5/27/21 all units affected on premises placed on hold and repaired with the recall remedy. 5/28/21 Incident details discussed at WIRC and elevated to CPAC for further research. 6/2/21 CPAC escalate to SSC with a recommendation of "Recall for Safety, 6/8/21 SSC reviewed details and approved recall.
