Description of Defect:

Description of the Defect: During production, certain subject trailers may have used a 1/8" bracket that

did not meet the minimum bend radius requirements to secure the shell of the trailer to the frame. These out-of-specification brackets may also have had

visible stress fractures.

FMVSS 1: NR FMVSS 2: NR

Description of the Safety Risk: The out-of-specification bracket may not provide sufficient support to secure

the shell to the trailer frame. Subject trailers using the out-of-specification bracket could result in the shell of the trailer detaching during transit,

presenting a risk to trailing vehicles and a road hazard.

Description of the Cause: The support bracket should use a 3/16 inch bracket within a specified

minimum internal-bend radius. On certain subject trailers, the supplier may have installed an out-of-specification 1/8 inch bracket that did not met the minimum internal-bend radius. The brackets may also have had visible stress

fractures.

Chronology:

6/27/2021: The shell of a 2021 MyPod trailer became detached while being hauled to a dealership. Xtreme learned of the incident and began investigating.

6/28/2021 through 6/29/2021: Xtreme reviewed records and contacted the supplier/integrator that installed support brackets used to secure the trailer shell to the frame.

6/29/2021: Xtreme's supplier confirmed that it had used a 1/8 inch, out-of-specification support bracket to secure the trailer shells.

6/29/2021: Xtreme determined that the out-of-specification bracket may not provide sufficient strength to secure the trailer shells. Accordingly, Xtreme determined that this condition constituted a safety-related defect.

Xtreme is not aware of any reports from consumers of failures or injuries related to this condition.

Description of Remedy:

Description of Remedy Program: Xtreme will inspect the trailers and frames to ensure that the in-

specification support bracket was used. For trailers sold to consumers and equipped with the incorrect bracket, Xtreme will replace the trailer frame, which will be equipped with the proper support bracket. Trailers still in dealer inventory will be inspected and repaired or returned to Xtreme as

necessary.

How Remedy Component Differs For trailers still in dealer inventories using the incorrect support brackets from Recalled Component: and that have no signs of damage to the frame, Xtreme will weld on a 4inch wide, 1/4" extruded angle bracket. For trailers that have any frame damage or that have been put into service on public roads with the incorrect support bracket, Xtreme will replace the trailer's frame, which will be equipped with the proper support bracket.

Identify How/When Recall Condition Xtreme halted production of the subject trailers on June 29, 2021. Xtreme was Corrected in Production: will restart production using an in-specification support bracket.
