Description of the Defect :	When the service door is not adjusted correctly, certain parts of the mechanism may misalign. When it happens, operating the emergency release handle still works and disengages the motor, but the mechanism may bind and not allow the door panels to part opened, even if a force is applied on them

Description of the Safety Risk :	If the service door is not adjusted correctly and the mechanism misaligns, occupants may not be able to open the service door using the emergency release handle, preventing occupants from using this exit to evacuate the vehicle in case of emergency. The exterior emergency release handle may also not allow people to open the service door from outside the vehicle, increasing the risks of injury in case of a fire in the passenger compartment

On May 14, 2021, Transport Canada transmitted a complaint following an inspection in the field that had identified vehicles presenting exterior emergency release handle malfunction.

To respond to the information request from Transport Canada that accompanied the complaint, an investigation was immediately started to determine the cause of the malfunction observed in the field and determine whether a defect existed.

It was determined that if the electric door is not correctly adjusted, the electric door mechanism may become misaligned and cause the release handle to malfunction. It was also discovered that the defect may also affect the interior emergency release handle.

On July 8, 2021, it was decided to recall the vehicles equipped with an emergency release handle, either interior or both interior and exterior.

No accident, injury or fatality has been reported to Micro Bird regarding the situation
