Description of Remedy:

Description of Remedy Program: The remedy program will involve inspecting the involved windows with a go/no-go gauge to determine if the seal has been compromised. If an issue is found Lippert will provide a replacement vent. You or your dealer must inspect the involved component as outlined on the attached instructions and submit a claim documenting the completed repair for payment of the labor charges. Lippert's Customer Service department may be reached via email at recall@lci1.com or via phone at 574-538-4514 if there are any questions. Lippert does not require advance contact or a pre-auth be obtained; labor allowance for the inspection is 0.4 and labor allowance for the repair is 0.5 with the original vent not required to be returned. Lippert will coordinate shipments of the needed inspection gauge as well as window vent with the RV manufacturer.

How Remedy Component Differs The remedy component was produced with the improvements including from Recalled Component: increasing the bond strength between the two panes of glass through the use of an adhesive backed glass spacer and different secondary sealant.
