Description of the A concern has been identified on certain 2020 to 2021 Model Year (MY) Land Noncompliance: Rover Defender 110 vehicles equipped with third row seats, where the owner's manual incorrectly states the third-row seating as being fitted with LATCH child seat fitments with top tethers. The affected vehicles are not equipped with the LATCH system in the third-row seats.

> The incorrect written instructions for the installation of a LATCH child seat for the third row on Defender 110 vehicles are not compliant to Federal Motor Vehicle Safety Standards (FMVSS) 225 S12 - Child Restraint Anchorage

Systems.

Chronology:

A Product Safety and Compliance Committee (PSCC) Investigation was opened on May 18, 2021, following a report from the United States market on a possible incorrect owner's manual instructions for the installation of a LATCH child seat system for the third-row seats in Land Rover Defender 110 vehicles. The PSCC directed an engineering team to investigate the issue and potential scope of vehicles.

Through June, 2021, the engineering team reported to the PSCC on the progress of investigation. The team found North American specification Defender 110 vehicles were not equipped with the LATCH child seat system with top tethers, and the owner's manual written instructions indicating the presence of a LATCH child seat in the third row were incorrect. The PSCC requested the validation of the scope of Defender 110 vehicles affected with third row seating.

The PSCC reviewed all the available information and scope of vehicles on June 22, 2021, and concluded that the issue should be progressed to the Jaguar Land Rover Recall Determination Committee (RDC).

The RDC reviewed the issue on July 22, 2021, and concluded that the issue represented a non-compliance for

FMVSS 225 S12 - Child Restraint Anchorage Systems, and that a voluntary non-compliance recall be conducted.

There have been no reported accidents, injuries or fires as a result of this concern.

Description of Remedy:

Description of Remedy Program: Owners will be mailed a supplement to be inserted into the handbook.

There will be no charge to owners for this repair.

The affected vehicles will be covered under Land Rover's new vehicle warranty program. Therefore, reimbursement for pre-notice remedies are not necessary because the affected vehicles are still under warranty.
