Description of the Defect : As stated by the defect notice received by Cummins, Inc. per recall 20E018: Excessive electrical heating within the fuel heater may create sufficient heat inside the fuel heater to cause plastic in the fuel heater to melt and potentially catch fire. It may also cause an engine stall.

FMVSS 1 : NR

Description of the Safety Risk : As stated by the defect notice received by Cummins, Inc. per recall 20E018: A fire, if undetected and uncontained, presents an increased risk of personal injury. An unexpected engine stall may increase the risk of a crash.

Description of the Cause : The cause is excessive electrical heating internal to the fuel heater.

Identification of Any Warning : As stated by the defect notice received by Cummins, Inc. per recall 20E018:

that can Occur : Melting of the fuel heater or fuel seepage from around the fuel heater may be visible during a service event, smoke may precede or accompany a fire or the engine may become increasingly difficult to start.
