Description of the Noncompliance : Subject lamps exceed the maximum permissible candela levels specified in Federal Motor Vehicle Safety Standard (FMVSS) N0. 108 at certain test points.

FMVSS 1 : 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS 2 : NR

Description of the Safety Risk : The increased photometric intensity does not comply with the requirements of FMVSS 108 and may adversely affect the vision of following drivers, increasing the risk of a vehicle crash without warning.

Description of the Cause : the lamps do not meet the requirements of the relevant standard.

Description of Remedy :

Description of Remedy Program : Customers will be instructed to contact Code 3 to obtain a filter kit (Part No CZ0199) free of charge. Installation of the filter kit will ensure that the lamps perform within the permissible photometric intensity ranges. All of the subject lamps would be covered under the ECCO/Code 3 warranty/good will program. Therefore, pursuant to 49 CFR 577.11(e), we request an exemption from the reimbursement plan requirements.

How Remedy Component Differs from Recalled Component : The remedy involves installation of a filter kit that will ensure the lamps perform within the permissible photometric intensity ranges.

Identify How/When Recall Condition was Corrected in Production : Component manufacturer shipments of the subject lamps were discontinued march 27, 2020 as part of a planned supplier changeover. Manufacturer planned to resume after product redesign and testing confirms compliance. The new part will be assigned PN: 79STTRBZ-D
