Notification of defect received from manufacturer in July 2021. Lippert Components notified Escape that Hehr 6400 Series windows manufactured between 10.01.2018 and 08.13.2020 are subject to this recall. Escape has received no warranty claims from customers in relation to this recall matter.

Description of Remedy :

Description of Remedy Program : Lippert Components will supply a gauge to be used to conduct an inspection of the vent portion of the 6400 Series windows, as well as a replacement vent if the original vent is found to have an adhesive bond issue. Escape requires no reimbursement plan for this recall as the remedy is being coordinated directly by Lippert, being the manufacturer of the part which is subject to this recall.

How Remedy Component Differs from Recalled Component : NR

Identify How/When Recall Condition was Corrected in Production : As per communication from Lippert Components, potentially defective units were built between 10.01.2018 and 08.13.2020. Escape Trailer Industries purchased and installed potentially defective units between 04.01.2019 and 09.30.2019.
