Description of the Noncompliance : The brake lamps (part# 79STTRBZ) exceed the maximum permissible candela levels specified in Federal Motor Vehicle Safety Standard (FMVSS) No. 108 at certain test points.

FMVSS 1 : 108 - Lamps, reflective devices, and assoc. Equipment

FMVSS 2 : NR

Description of the Safety Risk : The increased photometric intensity does not comply with the requirements of FMVSS 108 and may adversely affect the vision of following drivers, increasing the risk of a vehicle crash without warning.

Description of the Cause : The lamps do not meet the requirements of the relevant standard.

On August 16th Boise Mobile was notified of a defect involving a stop tail turn light used on a vehicle built in 2016. The light does not meet Federal Motor Vehicle Safety Standard (FMVSS) No. 108 at certain test points. So we are initiating the recall/ repair of this vehicle.

## Description of Remedy :

Description of Remedy Program : Boise Mobile will assist the affected customer in reaching out to Code 3 / Ecco Group directly to request two filter kits (Part number CZ0199) free of charge that will ensure that the lamps perform within the permissible photometric intensity ranges.

How Remedy Component Differs from Recalled Component : The remedy involves installation a filter kit that will ensure that the lamps perform within the permissible photometric intensity ranges.

Identify How/When Recall Condition was Corrected in Production : There was no subsequent use of the light in question.
