Description of the Defect: The cotter pin that retains the brake pedal clevis pin (i.e. mounting shaft) may

not have been properly installed.

Description of the Safety Risk: If the cotter pin comes out, the clevis pin may work loose from the brake

pedal mounting bracket, which can affect the operation of the brake pedal and the ability to stop the vehicle. This presents a risk of a vehicle crash.

Mack has not received any reports of vehicle crashes. Out of an abundance of

caution, we are asking customers to park these vehicles until they are

inspected and cleared or repaired.
