Description of Defect:

Description of the Defect: On a small batch of motorcycles, the side stand may not have been

manufactured correctly. An improper weld that joins the tube to the forged part could affect the reliability of component. Ducati has never received reports

of injuries.

Description of the Safety Risk: Due to an improper weld, the side stand may be compromised and separate at

the weld. If the defect occurs, the side stand could break at the weld that joins the tube to the forged part on the top. The bike could fall down increasing the

risk of injury.

Description of the Cause: The cause for this is an improper weld that joins the tube to the forged part.

Identification of Any Warning If the defect occurs, the side stand could deform and the motorcycle could lean

Chronology:

In September 2020 Ducati received a report from the field about a broken side stand that caused the motorcycle to fall down to the ground. An investigation was started at that time.

During this investigation, Ducati became aware of a total of 10 field cases worldwide. Of these, 7 cases complained that the side stand bent excessively and 3 cases complained that the side stand broke, causing the motorcycle fall to the ground. None of these cases involved any injuries.

The result of the investigation, with the support of the side stand supplier, has defined the root cause as a possible non-conforming weld in a specific and defined side stand production batch.

Ducati has identified the motorcycles where the possible non-conforming side stands were installed.

On September 21, 2021, Ducati Motor Holding's internal safety commission decided to launch a recall campaign to address this condition in the affected population.

Description of Remedy:

Description of Remedy Program: Ducati North America will notify dealers and owners of this recall in

accordance with the notification schedule. Dealers will be instructed to install a new side stand, free of charge, per Ducati North America Recall Bulletins, which will be published to the Ducati Dealer Network using the

established communication process.

Requests for reimbursement for pre-notification repairs will be

considered in accordance with Ducati's general reimbursement plan on file

with the agency.
