Description of the Defect : The 12V wiring to the battery from the inverter is 2 Gauge whereas it should be 0/0 (both positive and negative), and is missing the 250AMP over-current protection within 18" of the battery, on the positive side. Additionally, the 110V side has a 20AMP double breaker, 12 gauge wiring from the distribution panel to the inverter, then 12 gauge wire to the first receptacle, then 14 gauge to three additional receptacles.

Description of the Safety Risk : The incorrect gauge wire could potentially melt, causing a short, which could potentially lead to a fire, property damage and/or personal injury.

Description of the Cause : The manufacturing plant improperly wired 12V and 110V

On October 14, 2021, during a routine Corporate Quality Control inspection the improperly wired inverter was identified.

On October 15, 2021, the manufacturing plant contacted Forest Rivers' Office of Corporate Compliance and an investigation was started.

On October 18, 2021, the vehicle scope was identified.

On October 22, 2021, Forest River's Corporate recall committee voted to recall.

The remedy is currently being determined, an amended 573 will be filed upon completion

Description of Remedy :

Description of Remedy Program : Forest River will provide all parts and labor free of charge to Consumers and Dealers. An authorized Forest River dealer will need to perform the remedy. A remedy has not been determined at this time. The 573 report and the NoD will be updated with the remedy once it is determined.

Identify How/When Recall Condition was Corrected in Production : The 12V wire gauges were changed to 0/0 gauge and a 250amp mini breaker was installed along with the 110V wiring was changed to all 12 gauge wire on all vehicles in Forest River possession the week of October 15, 2021.

Forest River will send suspected VIN numbers to our third party vendor that is licensed to pull data on the current owner of the vehicles (as needed) once a formal NHTSA I.D. is provided. Forest River intends on pushing the mailing out as soon as NHTSA provides any correction(s) and an Acknowledgement Letter.
