Description of the Defect :	According to 21E-085, "certain power steering pumps supplied by ZF may cause pressure to build and the shaft seal to leak into the engine, resulting in a loss of power steering assist in the identified recalled vehicles. ZF's understanding is that its power steering pumps operate under conditions specific to each vehicle application."

Description of the Safety Risk :	A sudden loss of power steering assist under certain conditions may increase the risk of a crash.
	Mack Trucks is not aware of any vehicle crashes associated with this safety defect.
Description of the Cause :	The rotor grinding process may have created an area of localized flatness in the end face of the steering pump motor during manufacturing of the power
	steering pumps.

Description of Remedy Program :	The repair will involve replacement of the suspect power steering pump. Repairs made prior to notification will be addressed according to Mack's General Reimbursement Plan on file with NHTSA.
How Remedy Component Differs from Recalled Component :	The remedy component does not contain the component defect that resulted in this filing.
	Action was taken by ZF to address the defect. When notification occurred to Mack Trucks, there were no actions required to remedy the vehicles in production as the vehicles had already been released.
