**Descriptive Information :** Great Dane received a number of pre-assembled axles that were deficient on lubricant fill in the wheel hubs. These axles were utilized to produce 2022 Model Great Dane Champion and Everest semi trailers in our Kewanee, IL, Jonesboro, AR, Elysburg, PA and Statesboro, GA, manufacturing facilities.

**Description of the Defect :** Certain 2022 Great Dane Everest Refrigerated, and Champion Dry Van trailers were produced using a supplier assembled axle that may have had deficient lubricant fill levels in the wheel hubs.

FMVSS 1 : NR

**Description of the Safety Risk :** Inadequate lubrication fill levels in the wheel hubs could lead to tapered roller bearings not receiving proper lubrication to support function. This could lead to a catastrophic failure of the hub bearings which could in an extreme case, cause the trailer's wheel/tire/hub assembly to become detached; increasing the possibility of a loss of stability and/or control of the vehicle leading to a crash. Further if the trailer's wheel/tire/hub assembly were to become detached it could create a hazard for other vehicles.

**Description of the Cause :** NR

**Identification of Any Warning that can Occur :** ABS may illuminate indicating excessive wheel end play.

Identify How/When Recall Condition was Corrected in Production : On 12/06/2021 SAF Holland began traveling to Great Dane manufacturing facilities to inspect and correct in-process and complete but not shipped equipment.
