This bulletin has been updated in the parts, warranty, and service procedure sections. This update includes new labor codes for both LD and HD vehicles and a new part number for the HD Pickup Front Passenger Airbag Inflator Kit and bracket. The new requirement information for recording the replacement air bag inflator serial number under the Warranty Information section has also been added to this bulletin. Please discard all previous copies of N212328770.

### **Important Reminders**

The new HD part numbers 84594241 (airbag kit) and 84594242 (bracket) must ONLY be submitted with the new labor code (9105714) AND with job card date of **June 28, 2021 or later** to avoid claim rejection. Vehicles repaired with the new part number 84594241 **MUST** have the serial number recorded when submitting the claim.

Dealers submitting for the previous HD part number 84255088 with a job card date **PRIOR to June 28, 2021** must use the previous labor code (9105358). Vehicles repaired with the previous part number 84255088 do not require recording of the serial number when submitting the claim for Priority Group 7.

### **Customer Letter Mailing**

All vehicles involved in N212328770 Priority Group 7 will be marked "Open" on June 28, 2021 or sooner in the Required Field Action section on the Investigate Vehicle History (IVH) screen. This site should always be checked to confirm vehicle involvement prior to beginning any required inspections and/or repairs.
