Issue:	The wheel bolt seat in the affected rims may not be machined to the correct depth dimension. If this condition is present, the incorrect dimension of the lug bolt holes may cause insufficient thread engagement of the wheel bolt to the wheel bearing hub. This may result in failure of the threads, which may lead to separation of the wheel from the vehicle and may lead to a crash without warning.					
Repair:	 REPAIR AVAILABLE – March 04, 2021 / Inspect all four wheels. Should an affected wheel be found, the wheel, lug bolts and wheel bearing will be replaced. See ELSA/ServiceNet for complete repair & claiming instructions Check both the daily Campaign Open Inventory report <u>and</u> OMD for affected vehicles in inventory. Verify OPEN status in ELSA <u>on the day of repair</u>. Repair every affected inventory vehicle <u>before delivery to consumers</u>.
