Customers will be notified via email, SMS, and targeted social ads (see samples below) every 21 days until the campaign concludes (or customers have no outstanding recalls).

Please refer to the online Recall Bulletins (Technical Service Bulletin) on MEDIC or Mitsubishi Dealer Link (MDL) for repair procedures and related parts information needed to properly complete these recalls. Please also plan to have parts on-hand to service these recalls.


