This is to notify you of the new Recall Campaign to check the mounting of the window airbag on <u>46</u> Model Year ("MY") 2021 247 (GLB-Class) vehicles. The recall campaign will be visible on the www.safercar.gov website and may generate questions from customers. Affected VINs will be flagged in VMI as "PENDING" on November 12, 2021.						
Background						
Issue		Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has determined that on certain GLB-Class vehicles (247 platform), the driver-side window airbag might not have been mounted in the lower area of the A-pillar according to specifications. In the event of a crash with activation of the driver-side window airbag, the catch strap of the driver-side window airbag in the lower area of the A-pillar could detach. Therefore, the restraining effect of the window airbag might not function as specified in FMVSS 226, possibly increasing the risk of injury for the driver and left rear occupant.				
What We're Doing		MBUSA will conduct a voluntary recall. An authorized Mercedes-Benz dealer will check the mounting of the driver-side window airbag on the affected vehicles and rework it, if necessary.
