IMPORTANT SAFETY RECALL

Dear Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Bridgestone Americas Tire Operations, LLC ("BATO") has determined certain Bridgestone and Firestone tires, identified in the table below, fail to conform with Federal Motor Vehicle Safety Standard (FMVSS) No. 139, *New pneumatic radial tires for light vehicles*. These tires were sold in both the original equipment and replacement tire markets. BATO has initiated a safety recall of these tires. You are receiving this letter because BATO's records indicate that you have purchased these tires or a new vehicle equipped with these tires.

WHAT IS THE PROBLEM?

Bridgestone has determined a small quantity of tires may have sustained a small pinhole in the outward-facing sidewall during the tire marking process. Affected tires with a pinhole penetrating the tire inner liner may slowly leak air. As such, these tires may not comply with FMVSS No. 139. If left undetected and/or unaddressed, this slow leak could affect tire performance and increase the risk of a crash.

WHAT PRODUCTS ARE INVOLVED?

This recall involves eight (8) tires in the following tire lines and sizes:

If you recently purchased any of the tires listed above, or a new vehicle equipped with these tires, your tires may be affected. Affected tires will have the numbers "2821" as the last four digits in the 11- or 13-digit Tire Identification Number ("TIN"). The TIN will be preceded by the letters

"DOT" and can be found on the lower portion of the outward-facing sidewall near the wheel rim (as shown in the photo below):



Because not all identified tires are affected by the condition, please see the "WHAT SHOULD YOU DO" portion of this letter for further instructions to determine whether your tires are affected and should be returned.

WHAT SHOULD YOU DO?

Not all the tires listed in the table above contain the pinhole condition. As such, BATO has developed inspection instructions that may be used to determine if your tires are affected by this issue. Inspection instructions, including a how-to video, are available at: https://www.bridgestoneamericas.com/en/tire-recall-information/august-2021.

If you are unable to perform the inspection or are uncertain as to whether a pinhole exists in your tire, you may bring your vehicle to a Bridgestone company-owned retail store or a Bridgestone/Firestone authorized retail location for a free tire inspection. To locate an authorized Bridgestone retailer near you, please visit https://www.bridgestonetire.com/dealer.

Any tire with a pinhole condition will be replaced with a comparable Bridgestone or Firestone tire at no charge to you. Replacement tires are currently available. This recall will remain open through March 18, 2022.

Important Note: The pinhole may not completely penetrate a tire's sidewall. If so, a tire may not lose air and your vehicle's tire pressure monitoring system ("TPMS") (if so equipped) may not alert to warn you of the sidewall condition. The only way to fully determine if a tire must be replaced is to visually inspect the sidewall to determine if a small hole is present near or within the first digit of the TIN Date Code. As shown in the photo below, the pinhole (if present) will always be located near the top of or within the first "2" of the 2821 date code. Again, if you are unable to perform the inspection or are uncertain as to whether a pinhole exists in your tire, you may bring your vehicle to a Bridgestone company-owned retail store or a Bridgestone/Firestone authorized retail location for a free tire inspection.



Federal law requires that any vehicle lessor receiving this notice must forward a copy of this notice to the lessee by First Class Mail within ten days of your receipt of this notice.

PROBLEMS OR CONCERNS?

If you have any problems or concerns about this recall, or if your Bridgestone company-owned retail store or Bridgestone/Firestone authorized retailer does not make the necessary replacements free of charge, please call 1-800-847-3272.
