Dear Mercedes-Benz Owner:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG, the manufacturer of Mercedes-Benz vehicles, has decided that certain Model Year 2017-2021 C-Class Cabriolet vehicles fail to conform to Federal Motor Vehicle Safety Standard ("FMVSS") number 208, "*Occupant crash protection.*" Our records indicate that your vehicle is included in the affected population of vehicles.

What is the CONCERN	On certain C-Class Cabriolet vehicles with PRE-SAFE, the front seat belts might not fully retract completely to their stowed position and therefore might not fulfill the requirements of FMVSS 208. If the seatbelt webbing does not fully retract into its stowed position, the seat occupant may find the operation of the seatbelt inconvenient and not wear it, increasing the risk of injury in the event of a crash.
What will your DEALE	<b>R DO?</b> An authorized Mercedes-Benz dealer will check the retraction function of the seat belt on the affected vehicles and adjust the damping foam within the B-pillar, if necessary. <u>This service will be provided free of charge.</u> We are dedicated to always delivering the best customer experience, and respect for your time is a top priority. While the minimum repair time can be less than <b>1 hour</b> , your dealer can provide you with a better estimate of the overall time for this service visit. As a matter of normal service process, an authorized Mercedes-Benz dealer will also check for other repair measures which might be applicable to your vehicle which may increase the required working time.
