What is the issue?

As a result, you may not receive information about open safety-recall campaigns.

An authorized Mercedes-Benz Sprinter dealer will update the VIN to reflect the accurate information and replace the vehicle certification label and the VIN label at the dash board on the affected vehicle. **This repair could take less than 1 hour**.
