This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. Keystone RV Company has decided that a defect which relates to motor vehicle safety exists in certain model 2019-2021 Aspen Trail, Bullet, Coleman, Cougar, Hideout, Passport, Springdale, Sprinter, and 2019 Fuzion, Impact, Kodiak, Residence, Retreat, Summerland Fifth Wheels and Travel Trailers. As a result, Keystone RV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall It has been decided that the Winn-Tec Model 6020 dual stage propane regulator may supply elevated, intermittent, or low propane pressure to the appliances. An increase in propane pressure, could cause the flame of the appliance to become larger, and under certain rare circumstances, may ignite adjacent materials resulting in a fire. Appliances that can be affected by an excessive flame are the stovetop, oven, water heater, furnace and refrigerator.

IMPORTANT

Keystone was able to confirm the regulator in your unit is either outside of the date range for the recalled regulator or a different brand of regulator altogether. Please inspect your regulator or take it to the dealer for inspection to confirm that it is not included in the recall using the pictures below. Please review the following information and contact Keystone Customer Service if you believe that this information is incorrect.

Please review the examples below. For the affected Model 6020 Winntec regulator shown in Figure 1, <u>only date codes 18 XX</u>, <u>19 XX</u>, <u>20 XX</u>, and <u>21 XX</u> are affected. Other units may have a Fairview brand regulator as shown in Figure 2 which is not under recall.
