Subject: Wide Base Tire and Wheel Combinations

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Daimler Trucks North America LLC (DTNA), on behalf of its Freightliner Trucks Division, and wholly owned subsidiary, Western Star Truck Sales, Inc., has decided that a defect that relates to motor vehicle safety exists on the vehicles mentioned above. Freightliner Custom Chassis Corporation has decided that a defect which relates to motor vehicle safety exists on specific model years 2011-2022 specific Freightliner 108SD, 114SD, Business Class M2, Coronado, and FLD Military vehicles and Western Star 4700, 4900, 6900, and 49X vehicles manufactured March 31, 2010, through September 22, 2021.

On the affected vehicles, the tire/rim combination was not on the approved list from the Tire and Rim Association or listed as approved by the tire manufacturer at the time of sale, as required by FMVSS 120. Failure to meet the standard without getting tire manufacturer approval increases the risk of a crash.

Vehicles with suspect tire/rim combinations will be replaced with approved tires. Repairs will be performed by Daimler Trucks North America authorized service facilities.

Please contact an authorized Daimler Trucks North America dealer to arrange to have the Recall performed and to ensure that parts are available at the dealership. To locate an authorized dealer, search online at Daimler-TrucksNorthAmerica.com/Contact-us. Scroll down to "Locate a Dealer" and select the appropriate brand. The Recall will take approximately one to three hours, depending on repair, and will be performed at no charge to you. You may be liable for any progressive damage that results from your failure to complete the Recall within a reasonable time after receiving notification.

If you do not own the vehicle that corresponds to the identification number(s) which appears on the Recall Notification, please return the notification to the Warranty Campaigns Department with any information you can furnish that will assist us in locating the present owner. If you have leased this vehicle, Federal law requires that you forward this notice to the lessee within 10 days. If you are a subsequent stage manufacturer, Federal law requires that you forward this notice to your distributors and retail outlets within five working days. If you have paid to have this recall condition corrected prior to this notice, you may be eligible to receive reimbursement. Please see the reverse side of this notice for details.
