IMPORTANT SAFETY RECALL - NHTSA Recall No. 21V-927

This notice applies to Your Lamborghini Aventador SVJ Roadster with the VIN

Automobili Lamborghini America LLC

Dear Lamborghini Owner, Lessee,

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Automobili Lamborghini S.p.A. has decided that a defect, which relates to motor vehicle safety, exists in your Model Year 2021 Aventador SVJ Roadster. Our records indicate that you are the owner of the vehicle in this recall.

What is the issue?

On your vehicle, the screws on the connection of the heat exchanger oil lines may not have been properly tightened during the assembly process. Confirmation of the correct mounting of the assembly cannot be ensured. Should the mounting assembly not be properly tightened, the heat exchanger oil lines could detach, and leak oil, which could potentially contact hot components increasing the risk of a fire.

For all the reason set forth above, it is therefore necessary to repair your vehicle. If you are not the only driver of this vehicle, please advise all other drivers and passengers of this important information.

What Do You Need to Do?

If an oil puddle is detected underneath your vehicle, please refrain from using it and, in any case, we encourage you to contact your authorized Lamborghini dealer to schedule an appointment to have this important free repair performed as soon as possible. Please bring this letter and your Service Booklet with you when you visit the dealer, so that we can make all necessary entries.

What will Lamborghini do?

We will check the mounting of the oil feed line and repair it if necessary, free of charge. The repair could take up to 01 (one) hour. We apologize for any inconvenience this recall may cause.

What if you are not the current owner of this vehicle?

You can update your vehicle ownership or contact information by filling out the enclosed document (Appendix A) and sending it to Lamborghini by following the instructions.

If you are a vehicle lessor, Federal Regulations require you to forward this notice to your lessee within ten days.
