### **Odometer**

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA US has decided that certain [2021 (JL) Jeep Wrangler PHEV] vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 571.101 – Controls and Displays, Section 4 which defines the odometer as an indicator that must display the magnitude of its sensed characteristic, which is defined under Safety Act 49 USC 32702 Definitions, as the distance driven.

It is extremely important to take steps now to repair your vehicle to ensure the safety of you and your passengers.

### WHY DOES MY VEHICLE NEED REPAIRS?

The odometer on your vehicle [1], after reaching 13,342 miles, will no longer display the magnitude of its sensed characteristic (mileage). The vehicle operator will notice that the odometer value is not displayed. If this warning is not heeded, a missing odometer reading may lead to missed or delayed critical vehicle maintenance. **Potential failed components, due to a lack of maintenance, may lead to a vehicle crash without prior warning.** 

## HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

FCA US will repair your vehicle <sup>[2]</sup> free of charge (parts and labor). To do this, your dealer will update the Instrument Panel Cluster (IPC) software if the vehicle has less than 13,342 miles, or replace the IPC on vehicles with more than 13,342 miles. The estimated repair time is 40 minutes. In addition, your dealer will require your vehicle for proper check-in, preparation, and check-out during your visit, which may require more time. Your time is important to us, so we recommend that you schedule a service appointment to minimize your inconvenience. Please bring this letter with you to your dealership.
