This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2022 KZ Connect models. As a result, KZRV is conducting a safety recall. **Reason for
this recall**

The vehicles subject to this recall were built with a propane line that is too close to a tire. The line could become damaged by debris which results in a gas leak that could result in a fire or explosion resulting in personal injury or death. This repair will be done at no cost to you.

**What we
will do**

The remedy is to reroute the propane line away from the path of the tire. The repair should take approximately 1 hour to complete.

**What we need
you to do**

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.
