When the error (and consequently) the warnings disappear, the passenger airbag works again as intended without any action/interaction necessary by the customer. In the event of a crash necessitating passenger airbag activation, there would be an increased risk of injury to the occupant seated in the front passenger seat if the passenger airbag is switched off/not working.

#### Red light flashes 1 times:

o General error.

#### Red light flashes 2 times:

- Battery voltage is too low.
- Programmer not connected to PODS seat harness.

- If the Red light flashes and there are no connection or voltage issues and the programming has been attempted multiple times (at least 10 times):
