### **Problem Description**

The headlights in vehicles affected by this recall did not have the required cap installed over the horizontal aim adjuster during vehicle production. This makes the headlights non-compliant with Federal Motor Vehicle Safety Standard (FMVSS) No. 108, *Lamps, Reflective Devices, and Associated Equipment*. Incorrectly adjusted headlights may result in reduced visibility for the driver and other motorists, which could increase the risk of a crash.

### **Corrective Action**

Remove the cap from the vertical aim adjuster on each headlight and install it on the horizontal aim adjuster.

### **Code Visibility**

On or about June 08, 2021, the campaign code will be applied to affected vehicles.

### **Owner Notification**

Owner notification will take place in June 2021. An owner letter example is included in this bulletin for your reference.

### IMPORTANT REMINDER ON VEHICLES AFFECTED BY SAFETY & COMPLIANCE RECALLS

New Vehicles in Dealer Inventory: It is a violation of federal law for a dealer to deliver a new motor vehicle or any new or used item of motor vehicle equipment (including a tire) covered by this notification under a sale or lease until the defect or noncompliance is remedied. By law, dealers must correct, prior to delivery for sale or lease, any vehicle that fails to comply with an applicable Federal Motor Vehicle Safety Standard or that contains a defect relating to motor vehicle safety.

<u>Pre-Owned Vehicles in Dealer Inventory:</u> Dealers should not deliver any pre-owned vehicles in their inventory which are involved in a safety or compliance recall until the defect has been remedied.

Volkswagen has decided that certain 2021 model year Volkswagen ID.4 vehicles fail to conform to with Federal Motor Vehicle Safety Standard (FMVSS) No. 108, *Lamps, Reflective Devices, and Associated Equipment*. Our records show that you are the owner of a vehicle affected by this action.

#### What is the issue?

The headlights in vehicles affected by this recall did not have the required cap installed over the horizontal aim adjuster during vehicle production. This makes the headlights non-compliant with Federal Motor Vehicle Safety Standard (FMVSS) No. 108, *Lamps, Reflective Devices, and Associated Equipment*. Incorrectly adjusted headlights may result in reduced visibility for the driver and other motorists, which could increase the risk of a crash.

### What will we do?

To correct this noncompliance, your authorized Volkswagen dealer will remove the cap from the vertical aim adjuster on each headlight and install it on the horizontal aim adjuster. This work will take less than an hour to complete and will be performed for you free of charge. 




## **Repair Instruction**

• Enter the VIN in Elsa and proceed to the "Campaign/Action" screen.

i TIP

On the date of repair, print this screen and keep a copy with the repair order.

- Confirm the Campaign/Action is open <arrow 1>. If the status is closed, no further work is required.
- Note the Applicable Criteria ID <arrow 2> for use in determining the correct work to be done and corresponding parts associated.






### Section B - Repair Procedure





- Work must be performed on <u>both</u> front headlights.
- Remove the sealing cap from the vertical adjustment screw <1> and move to the horizontal adjustment screw <2>.

# i TIP

Using a straight pick to guide the cap into the horizontal adjustment screw will aid in installation and reduce the chances of the cap being lost.

- Ensure the sealing cap is fully seated into the horizontal adjustment screw.
- If a cap is missing, lost or damaged, it must be replaced.
- If the sealing cap is already installed on the horizontal adjustment screw <2>, do not remove the cap.
