Solution for the field:

The safety belt retractor will be inspected for correct function and, if necessary, replaced.

Operations:

- **OPTION A:** Rear seat belt middle position inspection. (NOT for South Korea)
- **OPTION B:** Rear seat belt middle position replacement.

Note:

Vehicles of South Korea market must be performed only with OPTION B.




Work instructions:

The updating procedure described here includes the following steps:



- II. Rear seat belt middle position replacement

Rear seat belt middle position ١. inspection


1. Put the safety belt across the empty vehicle seat and insert the metal tongue of the belt into the buckle.




2. Pull the safety belt all the way out of the retractor to activate the Automatic Locking Retractor (ALR).



3. Carefully let the safety belt retract fully into the retractor while the belt remains buckled. which simulates a restrained child seat. You will notice that when in ALR mode, there is a ratcheting/clicking noise from the retractor. This is normal.



4. Grasp the torso portion of the safety belt and carefully pull on the belt in an attempt to pull the belt back out of the retractor. The belt should not pull out of the retractor.



- 5. Unlatch the belt, and let it completely retract back into the retractor.
- 6. Repeat steps 1-5 five times (a total of 6 cycles).

Conclusions of inspection

Case 1

If the safety belt locked so that the strap cannot be pulled out of the retractor in step 4. The ALR function works properly and the safety belt assembly meets the requirements. Don't replace the rear seat belt.

Case 2

If the safety belt has not locked so that the strap can be pulled out of the retractor in step 4. ALR does not work properly, the safety belt must be replaced according to the repair instructions.

II. Rear seat belt middle position replacement

To replace the rear seat belt follow the instructions on the workshop manual at the path:

08 Body → Passive safety systems → Rear **Center Safety Belt**
