# Safety Recall Y88 / NHTSA 21V-871 HVAC System

### Remedy Available

**2022** (DT) Ram 1500 Pickup

NOTE: Some vehicles above may have been identified as not involved in this recall and therefore have been excluded from this recall.

IMPORTANT: Some of the involved vehicles may be in dealer new vehicle inventory. Federal law requires you to complete this recall service on these vehicles before retail delivery. Dealers should also consider this requirement to apply to used vehicle inventory and should perform this recall on vehicles in for service. Involved vehicles can be determined by using the VIP inquiry process.

### **Subject**

The Heating, Ventilation, and Air Conditioning (HVAC) system and radio combination on about 22 of the above vehicles may be incompatible and not allow occupants to activate the defrost function. There is no warning to the driver that the defrost function is unavailable. However, the driver may notice that the defrost system is not functioning by the lack of air flow from the defrost vents and the reduced visibility due to the windshield not defrosting/defogging. The inability of the driver to activate the defrosting and defogging system can result in reduced visibility in some conditions, which can cause a vehicle crash without prior warning.

The condition described above does not comply with Federal Motor Vehicle Safety Standard (FMVSS) No. 571.103 S4.1 requires that "Each vehicle shall have a windshield defrosting and defogging system." Suspect vehicles do not have a windshield defrosting and defogging system that is operable by the driver.

## Repair

FCA US will repurchase the affected vehicles based on the fair market value of the vehicle based on its mileage and condition (less any modifications) using publicly available third-party valuation tools. The dealer or FCA US Customer Care will make arrangements with the vehicle owner for a final appraisal of vehicle value.

## **Dealer Notification**

### **Owner Notification and Service Scheduling**

All involved vehicle owners known to FCA are being notified of the service requirement by first class mail. They are requested to schedule appointments for this appraisal with their dealers. A generic copy of the owner letter is attached.

## Vehicle Lists, Global Recall System, VIP and Dealer Follow Up

All involved vehicles have been entered into the DealerCONNECT Global Recall System (GRS) and Vehicle Information Plus (VIP) for dealer inquiry as needed.

GRS provides involved dealers with an <u>updated</u> VIN list of <u>their incomplete</u> vehicles. The owner's name, address and phone number are listed if known. Completed vehicles are removed from GRS within several days of repair claim submission.

To use this system, click on the "Service" tab and then click on "Global Recall System." Your dealer's VIN list for each recall displayed can be sorted by: those vehicles that were unsold at recall launch, those with a phone number, city, zip code, or VIN sequence.

Recall VIN lists may contain confidential, restricted owner name and address information that was obtained from the Department of Motor Vehicles of various states. Use of this information is permitted for this recall only and is strictly prohibited from all other use.

## **IMPORTANT SAFETY RECALL**

### **HVAC System**

Dear [Name],

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

FCA has decided that certain [2022 model year (DT) RAM 1500 Pickup] vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) No. 571.103 S4.1 - which requires that "Each vehicle shall have a windshield defrosting and defogging system." Suspect vehicles do not have a windshield defrosting and defogging system that is operable by the driver.

It is extremely important to take steps now to ensure the safety of you and your passengers.

#### WHY DOES MY VEHICLE NEED REPAIRS?

The Heating, Ventilation, and Air Conditioning (HVAC) system and radio combination on your vehicle [1] may be incompatible and not allow occupants to activate the defrost function. There is no warning to the driver that the defrost function is unavailable. However, the driver may notice that the defrost system is not functioning by the lack of air flow from the defrost vents and the reduced visibility due to the windshield not defrosting/defogging. The inability of the driver to activate the defrosting and defogging system can result in reduced visibility in some conditions, which can cause a vehicle crash without prior warning.

#### HOW DO I RESOLVE THIS IMPORTANT SAFETY ISSUE?

FCA US will offer to repurchase your vehicle. <sup>[2]</sup> FCA US' offer to repurchase your vehicle will be based on the fair market value of your vehicle based on its mileage and condition (less any modifications) using publicly available third-party valuation tools. Your dealer will assist you in making arrangements for a final appraisal of your vehicle.

## TO SCHEDULE THE REPURCHASE OF YOUR VEHICLE, CALL YOUR CHRYSLER, DODGE, JEEP OR RAM DEALER TODAY

#### WHAT IF I ALREADY PAID TO HAVE THIS REPAIR COMPLETED?

If you have already experienced this specific condition and have paid to have it repaired, you may visit <u>www.fcarecallreimbursement.com</u> to submit your reimbursement request online. [3] Once we receive and verify the required documents, reimbursement will be sent to you within 60 days. If you have had previous repairs performed and/or already received reimbursement, you may still need to have your vehicle repurchased.
