# Safety Recall: 2021 Ridgeline Second Row Center Seat Belt Replacement

Supersedes 21-091, dated November 19, 2021, to revise the information highlighted in yellow.

# **REVISION SUMMARY**

Under REPAIR PROCEDURE, a step was removed.

# BACKGROUND

The automatic locking retractor (ALR) function on the second row center seat belt assembly may improperly deactivate. If the seat belt webbing is pulled out to the end and the ALR deactivates, the seat belt webbing can retract or extend freely, preventing proper child seat restraint with the seat belt. ALR deactivation does not comply with the requirements of FMVSS 208, Occupant Crash Protection, increasing the risk of injury to the child seat occupant.

#### **CUSTOMER NOTIFICATION**

Owners of affected vehicles will be sent a notification of this campaign.

Do an iN VIN status inquiry to make sure the vehicle is shown as eligible.

Some vehicles affected by this campaign may be in your new or used vehicle inventory.

Failure to repair a vehicle subject to a recall or campaign may subject your dealership to claims or lawsuits from the customer or anyone else harmed as a result of such failure. To see if a vehicle in inventory is affected by this safety recall, do a VIN status inquiry before selling it.

# **CORRECTIVE ACTION**

Replace the second row center seat belt.





## **REPAIR PROCEDURE**

1. Remove the left rear under-seat trim panel.




2. Remove the center rear seat belt lower anchor.



- 3. Remove the rear seat.
- 4. Remove the rear trim panel.
- 5. Remove both C-pillar trims.
- 6. Remove both rear seat side trims.
- 7. Remove the sub-woofer.
- 8. Move the rear window center glass regulator and set it aside (if equipped).

9. Remove the rear panel insulator.




10. Cut the webbing on the rear center seat belt.



11. Remove center rear seat belt upper anchor.



12. Remove the rear center seat belt assembly.



13. Install the new rear center seat belt assembly and torque the bolt to 39 N.m (29 lb-ft).

- 14. Torque the upper anchor bolt to **39 N.m (29 lb-ft)**, the lower anchor bolt to **47 N.m (35 lb-ft)** and the center rear seat belt guide to **9.4 N.m (6.9 lb-ft)**.
- 15. Install all parts in the reverse order of removal.
