Dear Valued Fleetwood Customer:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. This is to inform you that your vehicle may contain a defect that could affect the safety of a person.

REV Recreation Group Inc. has decided that a safety defect relating to motor vehicle safety exists on products within model year 2017-2021 Fleetwood brand gasoline motorhomes.

WHAT IS THE PROBLEM?

The P Model motorhomes affected by this recall have areas in the floor for wiring harnesses and heat ducts to pass through that were not properly sealed.

Identify any warning which can precede or occur: This condition may allow noxious air or gases to enter the living area, which could cause headache, nausea, loss of consciousness or death over prolonged exposure.

WHAT SHOULD YOU DO?

Please make certain your motorhome is immediately inspected and repaired by contacting an **authorized REV Recreation Group servicing dealer**.

WHAT WILL REV RECREATION GROUP DO?

With your continued satisfaction in mind, it is our intention to have these repairs made at your convenience with as little disruption as possible. Effective immediately, REV RV dealers have been supplied with all the information needed to enable them to inspect, and if necessary, properly seal all openings and gaps.

The repair should take approximately five to seven hours to complete; however, because of service scheduling times, your dealer may need the vehicle for a longer period of time. This service will be performed for you free of charge.

When you deliver your motorhome for repairs, your dealer will complete a **Repair Order**. Upon completion of the repair, please sign the **Repair Order** and fill out the enclosed self-addressed **Vehicle/Owner Information Update Card** and return it to REV Recreation Group.

If you have changed your address or sold the motorhome, please take a moment to provide the name and address of the person or dealership you sold it to on the enclosed **Vehicle/Owner Information Update Card** and return it to REV Recreation Group. This will allow us to update our records and if necessary, notify the new owner using the information you provide.
