**SAFETY RECALL RENOTIFICATION  
 OWNER RENOTIFICATION 23R003 AND DEALER OUTREACH UPDATE**

Toyota plans to conduct Safety Recall follow-up notifications to owners whose vehicles have not yet had the following Safety Recall repairs completed. Additionally, to provide dealers the opportunity to conduct outreach on newer campaigns, some older campaigns will be removed from LEO. *Campaign status information on unremedied vehicles remains available for individual vehicle VIN lookup on these vehicles.*
