<u>RENOTIFICATION</u> Dear «Owner_name»:

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act. KZRV has decided that a defect which relates to motor vehicle safety exists in certain 2022 Stratus and 2022 SportTrek models. As a result, KZRV is conducting a safety recall. We apologize for any inconvenience this action may cause you; however, your safety and continued satisfaction are of the utmost importance to us.

Reason for this recall

The vehicles subject to this recall were built with two incorrect circuit breakers. Under certain conditions the circuit breakers may not trip and could result in a fire resulting in property damage, personal injury or death. This repair will be done at no cost to you.

What we will do The remedy is to change the 20 Amp circuit breaker which controls the water heater circuit and the 20 Amp circuit breaker which controls the fireplace circuit with the proper 15 Amp circuit breakers. The repair should take approximately 30 minutes to complete.

What we need you to do

You should contact your selling dealer immediately to schedule a service appointment to have the defect repaired in your vehicle.
