Dear Valued Freightliner Sprinter Owner:

This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG (“MBAG”), the manufacturer of Freightliner Sprinter vans, has decided that a defect which relates to motor vehicle safety exists in certain Model Year 2019 - 2021 Freightliner Sprinter vehicles. Our records indicate that your vehicle is included in the affected population of vehicles.

What is the concern?



On certain Freightliner Sprinter vans the MBUX multimedia system software might not meet specifications. Under very specific conditions, the MBUX multimedia system might not start and the display might remain black, or could reboot unintentionally after 50 seconds of initial startup. Accordingly, the rearview camera image might not be displayed or the display might be interrupted, which could increase a risk of a crash or injury.

Unfortunately, the software to remedy this are not yet available.

We are working to obtain the necessary software to correct this condition as quickly as possible. When the software become available, we will send you another letter asking you to take your vehicle to an authorized Freightliner Sprinter dealer to have the recall completed free of charge.

We apologize for any inconvenience this may have caused and look forward to taking care of this important safety issue immediately.
