Dear Mercedes-Benz Owner,

This notice is sent to you in accordance with the requirements of the National Traffic and Motor Vehicle Safety Act.

Mercedes-Benz AG ("MBAG"), the manufacturer of Mercedes-Benz vehicles, has decided that certain Model Year ("MY") 2018-2021 GLE-Class, C-Class, A-Class and GLB-Class vehicles fail to conform to Federal Motor Vehicle Safety Standard (FMVSS) number 108, "*Lamp, Reflective Devices and Associated equipment*". Our records indicate that your vehicle is included in the affected population of vehicles.

What is the Concern?

In certain MY 2018-2021 GLE-Class, C-Class, A-Class and GLB-Class vehicles with Light Emitting Diode "LED" headlamps, the headlamps might be incorrectly adjusted, and not meet current production specifications. In this case, the light intensity of the high beam, low beam, and the model-specific turn signal indicator may not conform to certain requirements of FMVSS 108. Incorrectly adjusted headlights may reduce visibility, which could increase the risk of a crash.

An authorized Mercedes-Benz dealer will replace the LED headlamps on the affected vehicles.

Unfortunately, the parts to remedy this are not yet available, but we are working to obtain them as quickly as possible. As parts become available, we will send you another letter asking you to take your vehicle to an authorized Mercedes-Benz dealer to have the recall completed free of charge.

Should you have any concerns or questions regarding your vehicle before you receive the next recall letter when remedy is available, please contact an authorized Mercedes-Benz dealer. If for any reason a dealer is unable to remedy your situation, we are always happy to hear from you. Please contact us at 1-800-367-6372. A vehicle identification number (VIN)-based recall lookup tool on our MBUSA.com website offers a search function that will indicate whether a vehicle has been subject to a safety recall, and whether that vehicle has had the free remedy performed. If you are no longer the vehicle owner, or have a change of address, please complete the reverse side of this letter and return the complete letter in the enclosed envelope. If this is a leased vehicle and the lessor and registered owner receive this notice, please forward this information by first class mail to the lessee within 10 days to comply with federal regulations.

If a Mercedes-Benz dealer for any reason is unable to remedy the situation without charge, or within a reasonable amount of time, pursuant to law 49 U.S.C.
