This notice is sent to you in accordance with the National Traffic and Motor Vehicle Safety Act. Porsche has decided that a defect that relates to motor vehicle safety exists in certain 2015-2018 Model Year Porsche Macan vehicles. Our records show that you are the current owner of a vehicle affected by this recall. We have sent you a previous letter concerning this Recall and this email serves as a follow up notice.

What is the issue?

On the affected vehicles, the front passenger seat occupancy sensor mats may degrade with time and eventually fail, leading to the possible non-detection of a front passenger. As a result, the front passenger airbag may not deploy in the event of a crash, increasing the risk of injury.

What will Porsche Do?

Porsche is conducting a safety recall to replace the passenger seat occupancy sensor mat. This remedy will be performed free of charge for parts and labor. Thank you for your patience and allowing us to help maintain continued satisfaction with your vehicle.

This is an important Safety Recall.

The remedy will take up to 4 hours to perform, however depending on the dealer's work schedule, it may be necessary to make your vehicle available for a longer period of time. This recall will be carried out at no expense to you. If you have previously paid to have this repair performed, you may be eligible for reimbursement. For more information, please contact customer support as instructed below.

What should you do?

The necessary remedy parts are now available. Please contact any authorized Porsche dealer to schedule an appointment to have this recall performed as soon as possible and to arrange for Porsche-provided alternate transportation, if necessary.

If the red air bag warning lamp is illuminated in the instrument cluster or the yellow "Passenger Airbag OFF" status lamp is illuminated in the overhead console when the front passenger seat is occupied by an adult, then do not use the front passenger seat until the issue has been remedied by your authorized Porsche dealer.
