Problem Description:

Chrysler (FCA US, LLC) is recalling certain Mopar right rear brake hoses with part numbers 68371722AA and 68371722AB, and left rear brake hoses with part number 68371723AB. The brake hose inside diameter may be too small, which could cause the hose to rupture. As such, these hoses fail to comply with the requirements of Federal Motor Vehicle Safety Standard number 106, "Brake Hoses."

Consequence:

A brake hose rupture can cause a loss of braking ability, increasing the risk of a crash.

Remedy:

Dealers will replace the hose, free of charge. If the hose is not installed on a vehicle, dealers will inspect the production date label and replace the hose as necessary, free of charge. Owner notification letters are expected to be mailed November 30, 2022. Owners may contact FCA US, LLC customer service at 1-800-853-1403. FCA US, LLC's number for this recall is ZA6.

Please be reminded of the following requirements:

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Under 49 U.S.C. § 30112(a), it is illegal for anyone, including a manufacturer, distributor, dealer, or retailer to sell an item of equipment or vehicle that fails to comply with all applicable Federal motor vehicle safety standards.

As stated in Part 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
