Problem Description:

Mercedes-Benz USA, LLC (MBUSA) is recalling certain 2022 AMG GT 43, AMG GT53, S500, AMG EQS, EQS450, EQS580, AMG GT63 S, C300, CLS450, AMG SL63, AMG SL55; 2021 AMG CLS53, AMG E63 Wagon S, AMG E63 S; 2021-2022 AMG

E53, E350, E450 Cabriolet, E450 Coupe, E450 Wagon, E450, AMG E53 Cabriolet, AMG E53 Coupe, S580, and Maybach S580 vehicles with a heated leather steering wheel. Due to a software error in the hand detection control unit, the hands-off detection might not detect when the driver's hands are away from the steering wheel when using the Active Distance Assist DISTRONIC system.

Consequence:

Deactivated hands-off detection will prevent DISTRONIC system features from functioning, including warnings to grab the steering wheel, Active Emergency Stop Assist, or calling first responders in the event of an emergency, which can increase the risk of a crash or injury.

Remedy:

Dealers will update the hand detection control unit software for the DISTRONIC system, free of charge. Owner notification letters are expected to be mailed May 20, 2022. Owners may contact MBUSA customer service at 1-800-367-6372.

Please be reminded of the following requirements:

You are required to submit a draft owner notification letter to this office no less than five days prior to mailing it to the customers. Also, copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
