This letter serves to acknowledge Tracker Marine, LLC's notification to the National Highway Traffic Safety Administration (NHTSA) of a safety recall which will be conducted pursuant to Federal law for the product(s) listed below. Problem Description:

Tracker Marine, LLC (Tracker) is recalling certain 2020-2023 Trailstar and Ranger Trail boat trailers. Please refer to the attached document for the full list of affected model numbers. The axle hubs were not tightened properly, which can cause the hubs to seize while in motion.

Consequence:

Seized trailer hubs can cause a loss of vehicle control, increasing the risk of a crash.

Remedy

Dealers will inspect and tighten the hubs, as necessary, free of charge. Owner notification letters are expected to be mailed in June, 2022. Owners are advised to drive at reduced speeds and not tow a boat, until the remedy has been performed. Owners may contact Tracker's customer service at 1-417-873-4555. Tracker's number for this recall is TS-0041.

Please provide the date in which Tracker Marine decided to file a recall with NHTSA.

AMENDED 573 REQUIRED.

Your company's program shall include a plan for reimbursing an owner or purchaser who incurred costs to obtain a remedy for the problem addressed by the recall within a reasonable time in advance of your company's notification of owners, purchasers and dealers, in accordance with § 573.13. Your company's plan may incorporate by reference a general reimbursement plan it previously submitted to NHTSA, together with information specific to the individual recall. Information required by § 573.13 that is not in a general reimbursement plan shall be submitted in your company's report to NHTSA. If your company submits one or more general reimbursement plans, your company shall update each plan every two years (§ 573.13). If the vehicles are new and would be covered under the manufacturer's warranty program, please state that in the remedy section of your filing.

AMENDED 573 REQUIRED.

An identification and description of the risk to motor vehicle safety reasonably related to the defect or noncompliance (49 CFR 573.6 (c)(5)). All filings should state an increased risk of either a crash, injury or fire.

AMENDED 573 REQUIRED.

Identification of the products recalled including valid dates of production (49 CFR 573.6 (c)(2)). Please amend the Part 573 report to specify exactly which model years are affected for both the Ranger Trail and Trailstar, as this information does not match the separate model list provided.

AMENDED 573 REQUIRED.

We have received Tracker's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.

Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
