Problem Description:

Forest River, Inc. (Forest River) is recalling certain 2021-2022 Cargo Mate Cargo Trailers and Continental Cargo Trailers. The safety chains do not meet the Gross Vehicle Weight Rating (GVWR) and could potentially break..

Consequence:

Safety chain breakage can cause the trailer to detach from the tow vehicle, increasing the risk of a crash.

Remedy:

Dealers will replace the safety chains, free of charge. Owner notification letters are expected to be mailed August 15, 2022. Owners may contact Forest River customer service at 1-254-420-0171. Forest River's number for this recall is 700-1530.

We have received Forest River's proposed owner notification letter and it is currently under review. You will be notified of any changes or concerns once our review is complete.



Please be reminded of the following requirements:

Copies of all notices, bulletins, dealer notifications, and other communications that relate to this recall, including a copy of the final owner notification letter and any subsequent owner follow-up notification letter(s), are required to be submitted to this office no later than 5 days after they are originally sent (if they are sent to more than one manufacturer, distributor, dealer, or purchaser/owner).

Please be reminded that under 49 U.S.C. § 30112(a)(3), it is illegal for a manufacturer, to sell, offer for sale, import, or introduce or deliver into interstate commerce, a motor vehicle or item of motor vehicle equipment that contains a safety defect once the manufacturer has notified NHTSA about that safety defect. This prohibition does not apply once the motor vehicle or motor vehicle equipment has been remedied according to the manufacturer's instructions.

As stated in Part 573.7, submission of the first of eight consecutive quarterly status reports is required within one month after the close of the calendar quarter in which notification to purchasers occurs. Therefore, the first quarterly report will be due on, or before, 30 days after the close of the calendar quarter.
