## **Chronology:**

On February 18, 2022, ZH Brothers International, Inc. ("ZH Brothers") was advised by its U.S. based distributor that it had been made aware of reports that some lug bolts in the 50 amp inlet could not be tightened to the specified torque level. ZH Brothers worked with its distributor which took steps to quarantine the product and ZH Brothers commenced a product review to better understand these reports. On March 2, 2022, ZH Brothers identified certain batches of 50 amp inlets where the metal used in the lug bolts material did not appear to have been produced to the specified hardness and began to produce new 50 amp inlets with correct lug material. The investigation found that if the lug bolts could not be properly tightened, there is a risk of electrical arcing in the gaps between the wire and inlet loosens over time. On March 11, 2022, ZH Brothers decided that a safety-related defect exists in certain 50 amp inlets.
