On May 9, 2022, Red Rock LLC ("Red Rock Supply") was advised by its U.S. based customer that it had been made aware of reports that some welds holding the pieces to the dinette table base were breaking and not holding to the proper weight rating. Red Rock Supply worked with its customers to quarantine the product and Red Rock commenced a product review to better understand these reports. On May 13, 2022, Red Rock identified certain batch of swing up table bases where the welds were not fully completed. On May 17, 2022, Red Rock decided that a safety-related defect exists in certain swing up table bases. There were no injuries before the recall was submitted. Also, there have been no injuries reported to date.
